

Koj txoj cai xaiv Koj kev tu mob tom ntej yuav ua li cas tu tau tus kheej yog koj pias tsis tau yam koj xav tau.

Xaiv kev tu mob tom ntej

Koj muaj txoj cai yuav xaiv txog yus tus mob. Koj xaiv tau tias kam lossis tsis kam phais lossis siv tshuaj. Koj muaj txoj cai yuav npaj ua ntej rau thaum koj xaiv tsis tau txog yuav tu tus mob li cas. Koj ua tau li no yog koj ua daim ntawv Advance Directive.

Qhov Advance Directive yog dabtsi?

Daim Advance Directive yog ib daim ntawv hais tias kev kho raws li koj xav thiab tsis xav tau. Nws piav ib yam kev tu mob yus txiav txim rau yus tus kheej raws li lub caj yus ua tsis tau rau yus tus kheej.

Koj qhov Advance Directive yog txog so koj xav tau dabtsi, kev ntseeg thiab kev ntaus nqi. Thaum koj sau lawm, koj yuav tsum xav so koj tus kheej yuav xav li cas txog txoj kev tuag thiab lub sijhawm yuav tuag.

Vim li cas ua qhov Advance Directive?

Qhov Advance Directives teb rau koj tus kheej thaum koj teb tsis tau rau yus tus kheej. Nws sau cia yam kev kho koj xav tau thiab tsis xav tau thiab xaiv tus tib neeg es yuav txiav txim kev tu mob rau yus. Qhov no tej zaum yuav ua kom yoog yim zog rau koj tsev neeg thiab pab lawm paub tej yam koj xav tau es tsis yog yuav sim tw.

Leeg twg ua qhov Advance Directive?

Koj ua tau qhov Advance Directive yog koj muaj 18 xyoo lossis rov saum thiab hlwb dhia zoo.

Kuv ua qhov Advance Directive li cas?

Lub lav Wisconsin ruas paub ob daim ntawv txog Advance Directives. Koj ua tau daim ntawv Living Will lossis daim ntawv txog Power of Attorney rau kev tu mob. Koj muab tau cov ntawv no tom kws kho mob lub tsev kho mob lossis tom lub Wisconsin Division of Health.

Koj tsis tas tau ib tug neeg hais plaub ntug ua cov ntawv, tabsi ob tus neeg yuav tsum pom koj sau npe ntawm cov ntawv. Daim ntawv qhia tias leeg twg ua tau lossis ua tsi tau tus povthawj.

Yuav ua li cas yog kuv tsis ua qhov Advance Directives?

Yog koj thas tsis tau rau koj tus kheej thiab tsis tau ua qhov Advance Directives, tus kws kho mob tej tsam noog koj tsev neeg, phooj ywg lossis txiv plig. Yog koj tus kws

kho mob tsis paub tseeg, yog koj tsev neeg tsis pom zoo raws li qhov txiav txim, koj tus kws kho mob tej zaum yuav noog lub tsev hais plaub kom xaiv ib tus neeg txiav txim rau koj. Tus neeg ntawm hu ua tus guardian (tus neeg saib xyuas txog yus lub neeg).

Kuv tus kws kho mob puas ua raws li Kuv qhov Advance Care Directive?

Tej cov kws kho mob thiab tsev kho mob loj tej zaum muaj cai lossis kev tseeg es lawm yuav tsis tau raws li ib cov Advance Directives. Qhov no tseem ceeb yuav ua rau cov neeg paub tseeb txog qhov koj xav tau thiab paub so lawm puas ua raws li koj daim Advance Directives.

Qhov Power of Attorney for Health Care yog dabtsi?

Qhov Power of Attorney rau daim ntawv health care cia koj xaiv lwm tus neeg txiav txim rau kev kho mob rau yus yog koj ua tsis tau rau koj tus kheej. Tus neeg no hu ua koj tus health care agent. Lawv yuav xaiv tej yam li lossis tsis tag kuaj yam loj, noj tej hom tshuaj lossis kom lawv pab koj thaum koj yuav tuag. Muaj tej yam tswv yim es koj tus kws kho mob ua tsis tau rau koj yog koj rov lus ua ntej thaum koj ua daim ntawv. Cov no yeeg muaj sau rau daim ntawv.

Thaum koj tus health care agent xaiv so yuav ua li cas rau koj, lawv yuav xav txog so koj xav ua dabtsi ua ntej thiab so dabtsi zoo tshaj. Tseem ceeb heev yog koj xaiv tus neeg paub koj zoo thiab tham txog so koj xav ua dabtsi.

Thaum koj sau daim ntawv, koj sau tau so koj xav tau dabtsi los tsis xav tau, li phais lossis ntxig yas pub mov.

Yog thaum koj sau daim ntawv tag, koj tus health care agent txiav txim tsis tau rau koj txog thaum ob tus kws kho mob xaiv tau, hauv ib daim ntawv, tias koj txiav txim tsis tau rau koj tus kheej lawm.

Living Will yog dabtsi?

Qhov Living Will qhia rau koj tus kws kho mob tias koj xav tuag kom zoo thaum muaj mob lossis tsaug mob es pab tsis tau lawv. Hais txog no, yog koj qhov mob ua rau koj no qab es koj hais tsis tau lus, qhov Living Will qhia tus kws kho mob kom tsis txob siv tej yam dhov rau koj lub cev nrov nrog lub machine kom koj ciaj.

Qhov living will tham rau koj thaum ob tus kws kho mob xaiv tau, hauv ib daim ntawv, koj ze caij tuag lossis koj tsis paub dabtsi lawm thiab yuav xaiv tsis tau so yuav ua li cas rau koj tus kheej.

Qhov txawv ntawd qhov Living Will thiab qhov Power of Attorney rau Health care yog dabtsi?

Qhov Living will siv thaum koj yuav tuag lossis thaum koj pw es tsis no dabtsi lawm. Nws qhia rau hais tias kam lossis tsis kam pab koj kom ciaj es siv lub machines.

Qhov Power of Attorney rau health care siv rau thaum koj txiav txim tsis tau rau koj kev mob. Koj tsis tag ze caij tuag lossis pw es tsis no dabtsi lawm. Nws tso cai rau lwm tus tso cai lawv txiav txim rau koj.

Kuv Puas Thas yuav Ob qhov Living Will thiab qhov Power of Attorney rau Health Care?

Koj tsis thas yuav ob qhov Living Will thiab qhov Power of Attorney rau health care. Yog koj muaj ob qhov ntawv, koj yuav tsum ua zoo kom tsis muaj teeb meem. Yog muaj teeb meem, tus kws kho mob yuav ua raws lid aim Power of Attorney rau health care xwb es tsis ua raws li qhov Living Will rau tag nrho cov ntawv sau tom qab Dec. 11, 1991.

Yog kuv hloov siab?

Koj tso tseg lossis ua daim tshiab pauv qhov Living Will lossis Power of Attorney rau health care thaum twg los tau. Cov ntawv muaj qhia so yuav ua li cas.

Kuv yuav tsum muab kuv daim ntawv qhia txog tias yuav cia leeg twg tso lus thaum kuv mob rau qhov twg?

Koj yuav tsum muab koj daim ntawv qhia txog tias yuav cia leeg twg tso lus thaum kuv mob cia ib qhov chaw koj tus kheej thiab lwm cov neeg nrhiav kom tau. Tsis txob cia rau ib qhov chaw es koj yuav tau muab xaiv. Qhia koj tsev neeg thiab koj tus neeg hais plaub ntug paub, yog koj muaj ib tug, hais tias koj muaj ib daim ntawv cia lwm tus tso lus thaum koj mob heev thiab so koj muab tso rau

qhov twg. Koj yuav tsum noog koj tus kws kho mob kom tuav ib daim txog koj so yuav cia leeg twg tso lus rau lawm kuaj koj thaum koj mob heev lawm es rov nrog koj cov ntaub ntawv.

Leeg Twg Yuav Pab Tau?

Koj tus kws kho mob pab tau koj kom koj nkag siab txog koj tus mob thiab yuav ua li cas kho koj tus mob kom zoo. Nws pab teb tau koj cov nqe lus txog koj daim ntawv tso cai rau lwm tus kuaj koj thaum koj mob heev.
